#### What is research data?

Research data is all the information we collect during research about you, your child and your family

## What is personal data?

Any research data that can identify you or your child is personal data (e.g. name, date of birth, address). Some more sensitive categories of personal data are known as **sensitive (or special category) data** (e.g. ethnicity, information concerning health).

# Why do we collect, use and store your personal data?

For the purpose of research in the public interest.

Personal and sensitive data we collect helps us to understand and describe the research findings. We will also collect some personal data to allow us to contact you about the research.

## What personal data will we ask you to give us to use in this study?

We will ask you to give us the following personal data to help us understand and describe the research findings:

- Your child's date of birth, gender, ethnicity, eligibility for free school meals,
- Information about your child's experiences related to anxiety and, where applicable, help-seeking for child anxiety problems
- Your age, relationship status, relationship to your child, gender, ethnicity, household circumstances, housing tenure
- Information about your family and your/your partner's: level of education, employment, housing

This project is funded by the National Institute for Health Research (NIHR) (RP-PG-0218-20010). The views expressed are those of the author(s) and not necessarily those of the NIHR or the Department of Health and Social Care.



- Video-recording of the meeting where school staff feedback questionnaire responses
- If you and/or your child take part in a discussion group or interview, audiorecordings of these sessions
- If you take part in the online and therapist support, audio-recordings of telephone sessions with a therapist and more detailed information about your child's anxiety, mood and general lifestyle

We will ask you to provide the following personal information to allow us to contact you about the research:

- Your child's name, your child's school name and year group
- Your name, address, telephone number, postcode, email address. .

## How will we keep your personal data safe?

- Personal data will be collected from you using a secure website, with end-to-end encryption and/or on paper, and using audio-recorders and video-recorders.
   Families who take part the online intervention, will be provided with more information about how we keep your personal data in this part of the research safe.
- Data collected on paper will be temporarily stored in locked filing cabinets, and once securely digitised will be stored on a secure University server and paper copies will be destroyed.
- Video-recording of feedback meetings and audio recordings of interviews and discussion groups will be temporarily stored on video-recorded and audio-recorder devices, and once transferred to a secure University server, will permanently deleted from video/audio-recorders.
- We will transcribe interviews and discussion groups, and will not include any information that could reveal your identity in transcriptions.

Your personal information will be stored under a unique ID. We will have a document that links your/your child's name and contact details to your unique ID and we will store this document separately from all other information we hold about you. All other information we collect about you and your family will be labelled with this unique ID. Files with video and audio-recordings will be labelled using your unique ID and will be stored separately from all other information we hold about you.

 Any data or findings from the research that is published will not identify you or your child. We may use direct quotes from interviews or discussion groups in publications, but this will not include any information that could identify you or your family.

## How long will we store your personal data?

We will only store your personal information for as long as it is required for research purposes and appropriate safe-guards are in place.

- 1. Consent forms: these will be stored for a minimum of 3 years after the end of the research project.
- 2. Video-recordings of feedback meetings will be stored for as long as is needed to inform the development of the procedures. This may include informing the development of scripts for training videos for school staff. This means the video files may still be needed beyond the end of the study. If this is the case, retention will be reviewed on a 6-month basis, and destroyed 1 year after the end of the research project, if not before.
- 3. Audio-recordings of interviews and discussion groups audio-recording will be stored until recordings have been transcribed, and transcriptions thoroughly checked. This means that audio files will be destroyed by the end of the study.
- 4. At the end of the project, we may invite you sign up to a mailing list for families and schools interested in receiving invitations to provide input on future related studies. We will retain contact details for parents and schools who give us permission to do so for this purpose.
- 5. Families who take part in the online intervention will be given the option to have ongoing access to the website for a period of 2 years, and personal data will be stored for as long as a parent/carer retains access to the online programme. Families who are offered the online intervention will be provided with more information about how long we store your personal data, prior to agreeing to take part in the intervention.

All other personal data we hold will be permanently destroyed at the end of the project (9<sup>th</sup> December 2020). Other research data we hold beyond the end of the project will not include any information that could identify you or your family.

If you withdraw from the research after 1<sup>st</sup> April 2020, we may continue to use and store your personal information for the purpose of the research.

# Who is responsible for protecting your personal information?

The University of Oxford is responsible for protecting your personal data (the 'Data Controller').

## What are your rights under data protection law?

You have certain rights under data protection law which are to:

- Withdraw your consent
- Access your personal data or ask for a copy
- Rectify inaccuracies in personal data that we hold about you
- Be forgotten, (i.e. your details to be removed from systems that we use to process your personal data)
- Restrict uses of your data
- Object to uses of your data, e.g. retention after you have withdrawn from a stud Some restrictions apply to the above rights where data is collected and used for research purposes.
